

## ACKM Schedule of Fees – 2012

The following is a table outlining the fees for courses conducted by ACKM. **Unless otherwise stated all fees are GST inclusive and include licensing fees, course manuals, workbooks and assessment fees.** In some cases, additional resources and texts may be required which is the expense of the student.

**Note:** Enrolment and payment of course fees are subject to ACKM's terms and conditions as outlined in the Policies & Procedures section of this prospectus or on the back of the ACKM enrolment form. **Included in the following fees is a once off enrolment fee of \$95 payable to ACKM for all Industry recognised professional qualifications offered by ACKM except the Cert IV of Kinesiology HLT42807 & the Diploma of Kinesiology HLT51507 where the RTO application fee is \$195.** These fees are only paid once regardless of how many professional qualifications you receive and does not apply if enrolling in any individual workshops offered by ACKM, however does apply should students upgrade to a professional qualification offered by ACKM or a Nationally Recognised program after enrolling in an individual workshop.

The following course fees are the fees payable to ACKM for the enrolment in all of the modules offered by ACKM completely. For students who may have completed these modules or similar training at other colleges and are requesting a Credit Transfer (CT) or a Recognition for Prior Learning (RPL), please contact ACKM to tailor an individual training program for you. Course fees will be adjusted accordingly based on the then program detailed for you. Note. A CT/RPL fee will also be payable based on courses that are requested to be recognised.

**Note:** As nationally recognized training, all fees associated with the two qualifications above are GST exempt. There is a once off application fee of \$195 to ICPKP Australasia as the national registered training organisation administering the Certificate IV in Kinesiology and the Diploma of Kinesiology. This fee is paid upon enrolment in the Certificate IV in Kinesiology through ACKM and is included in the Certificate IV fees above. Students, who are enrolling in the Diploma of Kinesiology with ACKM and have completed the Certificate IV in Kinesiology through another institution, would need to add this \$195 RTO application fee into the above Diploma fees.

## Advanced (Post Graduate) Individual Kinesiology Training Workshops offered by ACKM

A number of additional qualifications may be offered from time to time through ACKM directly. When advertised Courses would be inclusive of GST and may be recognised by the Australian Kinesiology Association (AKA) and / or the Australian Institute of Kinesiologists (AIK) and used towards Continuing Education credits..

Note: Students may enrol in and complete the above courses independently as special interest workshops or as part of the Professional Training programs offered by ACKM. Should students enrol in any of the above courses individually and then choose to upgrade to a recognised professional training program or a nationally accredited qualification with ACKM, students would receive a direct RPL (recognition of prior learning) for applicable workshops completed with ACKM and receive a financial credit based on the allocated fees set for the individual modules RPLed within the recognised professional training program or a nationally accredited qualification. Should students enrolling or upgrading to a recognised professional training program or a nationally accredited qualification with ACKM apply for a RPL for similar workshops completed with training institutions other than ACKM, then a RPL fee will apply. Once the application is processed and the RPL is granted, the student will also receive a financial credit based on the allocated fees set for the individual modules within the recognised professional training program or a nationally accredited qualification. In addition, it is important to understand that our classes are limited in size and enrolments are accepted on a first-come first-serve basis. You are requested to lodge your enrolment and deposit with us as early as possible to ensure you have a seat reserved in our upcoming intake. Express payments up front need to be finalised within 7 days before the commencement of the college semester you enrolled in. Payments may be made by cheque, credit card, money order, direct debit. All credit card transactions incur an additional 2.5% processing fee.
